HOLD HARMLESS AGREEMENT

This HOLD HARMLESS AGREEMENT (this "Agreement") is made and entered into by and between the ("Indemnitor"), also referred to as "Vendor", and MCLEAN MOTORSPORTS PRODUCTIONS, LLC, d/b/a BAMA COAST CRUISIN' the ("Indemnitee"), also referred to as "Motorsports". In consideration of being allowed to participate in a Motorsports' Auto Show, or other Motorsports' sanctioned or sponsored event, Vendor agrees to indemnify and hold harmless Motorsports with respect to any and all liabilities Motorsports may incur as a result of Indemnitor's participation in any Motorsports' event.

- 1. Indemnification of Motorsports. - 2. Successors and Assigns. This Agreement shall be binding upon the parties hereto and their respective successors and assigns (including the direct or indirect successor by purchase, merger, consolidation or otherwise to all or substantially all of the business or assets of the Indemnitor), spouses, heirs and legal representatives.
- 3. Modification and Waiver. No supplement, modification or amendment of this Agreement shall be binding unless executed in writing by all of the parties thereto. No waiver of any of the provisions of this Agreement shall be deemed or shall constitute a waiver of any other provisions of this Agreement nor shall any waiver constitute a continuing waiver.
- 4. Notices. All notices, requests, demands and other communications under this Agreement shall be in writing and shall be delivered to the parties at the addresses on file for such parties at Indemnitor from time to time.
- 5. Applicable Law. This Agreement and the legal relations among the parties shall be governed by, and construed and enforced in accordance with, the laws of the State of Alabama, without regard to its conflict of laws rules.
- 6. Insurance. Vendor agrees to maintain General Liability Insurance and to provide proof of same to Motorsports, and upon request identify Motorsports as an Additional Named Insured under any such policy of insurance.
